INVITATION TO BID

2015 REPAIR OF THE SCHOOL BUILDING PROGRAM

(Project No. 15-01-001)

The Department of Education (DepED) Division of Camiguin, through the R.A. FY 2014 Government Appropriations Act (GAA), intends to apply the sum of the *2015 REPAIR OF SCHOOL BUILDING PROGRAM* intends to apply the sum of FIVE MILLION ONE HUNDRED FIFTY SIX THOUSAND SIX HUNDRED SIXTY SEVEN Pesos (=Php=5,156,667.00), being the Approved Budget for the Contract (ABC), to eligible payments under the contract for the “Repair of Classrooms Maac Elementary School, Benoni Elementary School, Mambajao Central School and Alangilan Integrated School”. Bids received that exceed the ABC per lot shall be rejected at bid opening.

The DepED Division of Camiguin through its Bids and Awards Committee (BAC), now invites bids for the above-mentioned works. Prospective bidders must have an experience of having completed at least **one (1) contract that is similar to the contract to be bid**, and whose value, adjusted to current prices using the NSO consumer price indices, must be at least fifty percent (50%) of the ABC to be bid. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships/partnerships, or organizations with at least seventy-five percent (75%) interests or outstanding capital stocks belonging to citizens of the Philippines.

A complete set of Bidding Documents may be inspected or purchased at the DepED Division of Camiguin BAC Secretariat, located at DepEd Division Office, B. Aranas St., Brgy Poblacion, Mambajao, Camiguin upon accomplishing a bidder's information sheet and payment in cash of a non-refundable fee, below 1 million (3,000.00), 1 million - 2 million (5,000..) only by the interested bidders to the DepED Division Cashier. Only bidders who purchased the Bidding Documents will be allowed to submit bids (ITB 6.8).

It may be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS), www.philgeps.net, and the website of the DepEd Camiguin, (www.depedcamiguin.com), provided that bidders shall pay the fee for the Bidding Documents not later than the submission of their bids.
